

REGIONAL ECONOMIC DEVELOPMENT COUNCILS

JULY 29, 2011

Throughout this week Governor Cuomo and Lieutenant Governor Duffy have traveled the State to announce the members of the Regional Economic Development Councils. As mentioned in your special update last week, under the new application process for economic development funding, the ten Regional Councils will be able to apply for state funding to support projects they determine to be part of their regional strategy using a new Consolidated Funding Application (CFA), making the projects eligible for grant money and tax credits from dozens of existing programs. The combined pool of funding accessible through the CFA totals up to \$1 billion.
